Alastair Borthwick is the Chief Financial Officer for Bank of America, and is a member of the company's executive management team.

In this role, Borthwick is responsible for the overall financial management of the company, including accounting, balance sheet management, financial planning and analysis, corporate treasury, investor relations, corporate investments and tax.

He is also one of the vice chairs for the company's Global Diversity & Inclusion Council.

Borthwick most recently served as president of Global Commercial Banking for Bank of America, a position he assumed in 2012. He led the Commercial Bank, one of the firm's eight lines of business, which delivers integrated banking solutions to clients across Middle Market Banking; Real Estate; Healthcare, Education and Not for Profit; and Dealer Financial Services.

Previously, Borthwick was a managing director and co-head of Global Capital Markets. In that role, he had responsibility for Equity Capital Markets, Investment Grade Debt Capital Markets, Leveraged Finance, and Global Origination for Rates & Currencies. Borthwick has also served as head of Global Investment Grade Debt Capital Markets. Borthwick joined the company in 2005, and spent the prior 12 years at Goldman Sachs.

Borthwick is a member of the board of directors of the Posse Foundation, one of the most comprehensive and renowned college access and youth development programs in the United States. He is also Vice Chair of BritishAmerican Business, the leading transatlantic trade association created as a result of the merger between the British-American Chamber of Commerce in the U.S. and the American Chamber of Commerce in the U.K.

Borthwick holds a masters' degree in business administration from the Amos Tuck School at Dartmouth College, and he graduated from the University of St. Andrews in Scotland where he majored in economics and statistics. He is a member of the Board of Advisors for Tuck.

In addition, she is a firmwide champion for Launch With GS, Goldman Sachs' \$1 billion investment strategy grounded in the firm's data-driven thesis that diverse teams drive strong returns.

Previously, Beth was global treasurer of Goldman Sachs and Chief Executive Officer of Goldman Sachs Bank USA, where she was responsible for the firm's funding, liquidity and capital management strategy. Prior to that, she held a variety of leadership positions in Interest Rates Products (IRP) trading, including global head of Short Term Macro trading, global head of Repo trading and cohead of US Interest Rate Products cash trading. Earlier in her career, Beth was a market maker on the IRP desk, where she traded a variety of instruments, focused primarily on options and later agencies. She joined Goldman Sachs in 1993 as an analyst in Debt Capital Markets and was named managing director in 2003 and partner in 2010.

Beth is chair of the Treasury Borrowing Advisory Committee and serves on the boards of Northwell Health and Math for America. She is a former member of the Treasury Market Practices Group and the Financial Research Advisory Committee.

Beth earned an AB in Quantitative Economics and History from Stanford University.

JENNIFER OPENSHAW CHIEF EXECUTIVE OFFICER GIRLS WITH IMPACT

Jennifer Openshaw — called "one of the most outspoken proponents for empowering women to control their financial lives" by CBS MarketWatch — is CEO of Girls With Impact, the nation's leading business education program for young women.

Her expertise and national reputation as a financial innovator have made her a valuable ally in the media — from "Oprah," "Dr. Phil" and "Today" to CNN, Fox and CNBC.

At the age of 14, Jennifer took on her first "real" job as a maid in a motel while her mother worked two full-time jobs as a waitress to support the family.

In 2000, Jennifer was named one of the Internet's 25 Rising Stars as a result of her work as CEO and founder of Women's Financial Network, a company created as a result of her experience in the industry and as the "Money Expert" for KCBS-TV. The company was acquired by Wall Street legend Muriel Siebert (NYSE: SIEB).

Jen's financial industry experience includes senior roles at Bank of America, leading pension advisor Wilshire Associates, and BankOne (now JP Morgan Chase). She also headed the 60-year-old Financial Women's Association and, most recently, was Partner and Chief Marketing Officer at global consulting firm Mercer, where she led the When Women Thrive research platform. She started her career in the California State Treasurer's Office.

Drawing from her experience in Silicon Valley, Wall Street and Main Street in tech, education, and the financial industry, Jennifer has been a fixture in the media. Her roles have included "Money Expert" for KCBS-TV, host of ABC Radio's Winning Advice, and columnist for Dow Jones' MarketWatch. She's the author of three books: The Socially Savvy Advisor (2015); The Millionaire Zone (Hyperion), based on research about the social networking strategies of the wealthy; and What's Your Net Worth? (Perseus), turned into a Public Television Show.

Jennifer has been an advisor to Fortune 500 firms, including Microsoft, where she also served as national spokesperson. She writes regularly for Dow Jones, USA Today and as a LinkedIn Influencer.

Jennifer holds an MBA in finance and BA from UCLA. She is a member of the New York Economic Club and was appointed by the California Governor to the Commission on California Government Efficiency.

- Primary program is a summer intensive program on a college campus and an online intensive program.
- Programs are geared towards college juniors interested in careers in investment management asset management. The program includes internships with leading asset management firms.



Grace Institute

WBC grantee since 2016

- Founded in 1897 by William R. Grace, a former NYC Mayor, the Grace Institute provides workforce development and training to women. Grace celebrated its 125th anniversary in April 2023.
- Grace empowers low-income women in the New York area to achieve employment and economic self-sufficiency by providing job-skills training, counseling, placement services and continuous learning opportunities that lead to upwardly mobile employment.
- Offers healthcare administration and general office administration tracks in a 14 week program 3 times each year.
- In 2023 Grace will serve 220 women, ages 18-64. Provides 1 year of support and helps place participants.

- RTSWS is a financial and investment literacy program designed to spark the interest of high school women towards careers in finance.
- The year-long academic program equips girls with the skills to succeed financially and potentially pursue a career in finance. WBC volunteers lead classroom workshops on money management, budgeting, allocating paycheck deductions, evaluating company stocks and bonds, stock market updates, salary negotiation, saving, and investing for retirement.
- WBC's inaugural program with RTSWS commenced in the Fall of 2022 and ran through Spring of 2023 and took place at the High School of Economics and Finance in downtown Manhattan.
- 40 high school students and 25 WBC volunteers participated in the first year of the program.

Savvy Ladies

- Founded in 2003, Savvy Ladies mission is to improve the financial well-being of all women; and to empower women to achieve financial independence.
- Savvy Ladies has helped over 25,000 women across the spectrum of ages, life experience, and income levels identify their goals and make proactive choices about their finances and their future.
- Savvy Ladies instills the importance of financial planning and provides women with the resources to make informed financial decisions for themselves and their families.
- Savvy Ladies addresses women's financial instability by providing free financial literacy services and financial education through courses/webinars and a helpline to help women build the knowledge and confidence they need to thrive and develop a financially stable future.


Girls with Impact
